The Central States Synod Women of the ELCA Board is inviting you to the 36th Convention of the Central States Women that will be held June 20-22, 2025, in Independence, MO. The theme of the convention is *Vessels of God's*

Grace, based on Ephesians 2:8.

"For by GRACE you have been saved through faith, and this is not of your own doing; it is the gift of God. (NRSV)

Our salvation comes through faith—not through our good works or anything we humans can do. Salvation is our free gift from God—there is nothing we can do to earn it! Salvation comes only from God, about which we humans cannot boast. Our convention speakers will be focusing on this wonderful gift of grace and how we can act as Vessels of God's Grace!

Convention Highlights—Stories of God's Amazing Grace

Grace changes people, and can lead, drive, and draw them in. It is a strong, active force that can be experienced. The upcoming convention promises to do just that, as stories of God's amazing grace are shared. Breakout sessions on Saturday will include:

Bible Study on Ephesians 2: 8 Rev. Kim Frederking

Pastor Kim is senior pastor at St. John's Lutheran Church in Salina, KS, and a creative Bible study leader and presenter. She shares that "a vessel filled to the rim with God's grace pours out beauty upon this broken world that all might receive healing. It does not pour out exhaustion, judgment, bitterness, anger, self-centeredness or self-right-eousness; it does not divide and diminish but invites and lifts up." This will be a grace-filled highlight of the convention for sure.

"Unconditional Love and Support for Survivors of Trafficking and Exploitation"

Heidi Olson & Roxie Loyd

Forensic nurse, Heidi Olson, teams up with Roxie Loyd from ReHope to share stories of grace in action. Heidi Olson, RN, SANE, has a wide range of experience in pediatric and forensic nursing care and trains healthcare workers to identify victims of trafficking and exploitation. Roxie Loyd is the Director of Programs & Services at ReHope, an organization which uplifts survivors through faith-based residence and recovery programs.

"Grace, Hospitality, and Assistance to New Refugees"
Sarah Kolsto

Sarah Kolsto currently serves as the Refugee Services Director at Della Lamb Community Services. Della Lamb is one of two refugee resettlement agencies in Kansas City. Sarah has spent the last ten years welcoming thousands of new neighbors seeking safety and peace after fleeing war and persecution. She aids families with housing, jobs, food, and language support from the first day of their 90-day journey toward self-sufficiency.

"Women of the Reformation" Evelyn Clark

Evelyn Clark attends Our Savior's Lutheran Church in Topeka, KS. Evelyn is well traveled, having visited Wittenberg four times with three tours focused on Luther and the Reformation. The Reformation changed the social, economic, and political structure of Europe, but Luther's work might not have been as effective had it not been for women. Who were these women, what did they do, and how did the Reformation affect the lives of women?

Our keynote speaker is Rev. Pastor Kendra Nolde, retired pastor of Gethsemane in St. Louis, MO. Since retiring from congregational ministry, she has served part-time on the synod staff as Director of Evangelical Mission and has served two interim positions.

The chaplain for the weekend is recently retired pastor Janice Hawley, mother of three, wife, teacher, and certified coach. She served as Mission Developer in the Central States Synod and recently served as pastor at Holy Cross in Creve Coeur, MO. Pastor Janice is passionate about the power of prayer and will host "Prayer Sisters" on Friday evening of the convention.

Our Offerings at Work

Greetings to all! Here in Central Missouri there is acute anticipation for the warm breezes and temperatures of spring after a winter of cold, snow, and ice. So too, our journey through this Lenten season is one of anticipation as we await the fulfillment of the promise of eternal life through the death and resurrection of Jesus Christ, our Lord. May God travel with each of you and bless you on this journey of faith and hope.

The fiscal year of the Central States Women of the ELCA closed on January 31, 2025, with a strong financial balance of



\$29,167.59. As noted in the previous newsletter, this balance is due largely to the fact that we did not hold a convention in 2024. The present balance of our GENERAL FUND is \$27,574.19, with additional offering yet to be deposited in the amount of \$1,548.38, which will bring our total balance to \$29,122.57.

The LYNN STARR EDUCATION SCHOLARSHIP FUND currently has a balance of \$3,537.00. In 2024, five women were each awarded a scholarship in the amount of \$550 for a total of \$2,750.00. Any donations from our units or from individuals to this fund would be greatly appreciated in order that we may continue to award substantial scholarships for women wishing to further their education. The application for the 2025 Lynn Starr Education Scholarship can be found in this issue or on the Central States Women of the ELCA web page. Women of the ELCA | Central States Synod. Please inform the women of your congregations about the availability of this scholarship.

Finally, the balance of the BARBARA NELSON SCHOLARSHIP FUND is currently \$17, 206.66. This is a substantial fund which is available for first-time attendees from the Central States Synod to be used for their registration (and other expenses) to attend the Triennial Gathering. In 2026, this churchwide event is being held right here in the Midwest, in Des Moines, IA! The dates of the Gathering are July 16-19, 2026. If you are a first-time attendee please plan to attend and make application for this scholarship.

As always, thank you for your generosity and support for the Central States Women of the ELCA.

Saved by Grace—Share by Giving



The recipient of the in-kind donations for our upcoming convention will be Della Lamb Community Services. This is a not-for-profit organization, founded in 1897 by Della C. Lamb, a United Methodist woman who responded to the needs of the Italian immigrant women by opening the first childcare center in Missouri. Since that time, Della Lamb has been committed to serving vulnerable women and children in Kansas City's historic northeast neighborhood.

In 2014, Della Lamb became a local refugee resettlement agency, serving as the first point of welcome for some of the newest members of the Kansas City community. Over the past 10 years, thousands have been welcomed from all over the globe—people seeking safety and peace after fleeing war and persecution. Some of these clients have spent decades in refugee camps, raising families while being displaced from their countries of origin. Although the current climate of anti-immigrant actions has presented new challenges to the organization, Della Lamb remains committed to providing support to the newest neighbors on their journey toward self-sufficiency in Kansas City.

A list of items requested for donation has been included in the convention registration packet. They include hygiene products and household cleaning supplies. Cash donations are surely welcome. Central States women are always generous with in-kind donations—let's make that happen again in 2025.



ReHope is a faith-based 501(c)(3) organization providing housing, treatment, and lifelong sustainment services for women and children victims of human trafficking. Formerly known as Restoration House of Greater Kansas City, ReHope began its mission in 2015 as a response to the increasing epidemic of sex trafficking in the United States.

The roots of prostitution and trafficking are often found in severe abuse, loss, and/or neglect. It is these traumatic experiences that make people vulnerable to being trafficked. As the staff members receive the women and children coming out of these horrible situations, they view them as survivors, and offer unconditional love and support without judgment.

Due to the deep-rooted trauma, ReHope believes the healing and restoration process is a long-term endeavor. Therefore, survivors are provided with individual attention and focused programming that promotes sustainable healing and ongoing support. Only then can these survivors move confidently toward healthy, self-sustained, independent living.

Call to Discipleship

Dear Sisters in Christ, how are you? This is my last love letter to you as your board member. I am grateful to you for the opportunity to be part of this wonderful ministry. I hope that you have plans to attend the convention in June.

I've shared a lot about discipleship over the time that I have served on the board and I appreciate the privilege to share with you one last time this CALL TO DISCIPLESHIP. As always, I'd like to share my story.

One day in 2002 my then pastor, the late Rev. Lilley, unexpectedly called me and told me I was chosen to attend the synod assembly that year as a person of color. I was shocked that he used the title, person of color and felt insulted as I had never had anyone prior refer to me in that manner. When I asked, Pastor Jeff Lilley, he kindly explained to me the meaning of person of color (POC) as a term that is used in our church language. Though I was not satisfied with the explanation,

I could not say 'no' and I attended my first synod assembly, met many wonderful people, and attended synod assemblies in the years that followed. During the 2005 synod assembly it was announced during the elections that the nominating committee had no candidate to fulfill the requirement for a *POC*. I thought that weird since I saw many *POCs* in the assembly. Suddenly I heard a dear pastor standing up announcing she had a person to nominate and called out my name. Well, I had no idea what it meant, she asked me to meet with her and in our time together she explained I had to say 'yes' and because she was a pastor, I trusted her. I was elected and served two consecutive terms on the council and on a mission budget team (2005-2011). I was surrounded by a great team of leaders and learned a lot from them that helped me when I became a pastor.

The *POC* term that I disliked did not stop there. In 2014 I was nominated to be on the ballot for the executive board of the Women of the ELCA as the *POC* by a sister who I had never met. Even to this day I don't know who brought my name forward. I served two terms on the board from 2014-2020. During that time I spoke at many conventions, sharing my story and was blest to connect with many sisters from all over the US. Many with whom I remain in contact, including the sister in Kenya.

One of our Central States Synodical Organization's presidents nominated me to be on the ballot for the organization's board. By now.....you must be wondering where I am going with this. Please, bear with me. These sisters obeyed the call to discipleship and realized to be a disciple is to make disciples—to identify someone and help them hear God's call towards discipleship.

I was the first *POC* pastor at St. Paul's Lutheran Church in Valley Falls, KS, the oldest Lutheran church in Kansas; at St. Mark's Lutheran Church in Atchison, KS; and St. Mark's Lutheran Church in Emporia, KS. I served at Cross of Glory in Derby, KS, and preached at many churches in Kansas where they had never heard preaching from a *POC* pastor before me. Dear sisters, God is not done with me yet—in January this year I got an invitation to preach at Upper Wolf Lutheran Church in Robinson, KS. Robinson is a town of 250 people, most of whom have never known a *POC* or surely not heard from *POC* pastor before. I am preaching regularly there.

All these faithful disciples took a chance to invite me to be their pastor to proclaim the good news, yes, a *POC* indeed. The title I disliked, *POC*, brought me to my knees to humbly obey God's call and continue to serve HIM and HIM alone. Therefore, my dear sisters, the call to discipleship is to make disciples for Christ. Where are you on you personal journey of discipleship and supporting others in their journey?

I love to tell the story of unseen things above, of Jesus and his glory, of Jesus and his love.
I love to tell the story, because I know it's true; it satisfies my longings as nothing else would do

Wilma passed away in January after a 3-month battle with an aggressive form of angiosarcoma. She is remembered as a 'glass-half-full' woman, who showed genuine hospitality to everyone and believed in gathering strangers around a table for conversation. She served as the president of the WELCA unit at St. Mark's congregation in Clayton, MO, for many years and most recently relished her role as one of the cluster coordinators for the Eastern Missouri Cluster. She enjoyed meeting women from across Kansas and Missouri and always looked forward to attending conventions and Triennial gatherings. Her smile brightened any room, and she never stopped praying and encouraging others. Thank you, God, for Wilma Prifti.

Nadine passed in February following a 2-year heroic battle with fallopian tube cancer. She will be remembered as a model for many—as a wife, mother, grandmother, teacher, and servant leader. In the midst of raising five small children, she found time to achieve two degrees and begin teaching in the area of special education, dedicated to students with special needs. Nadine's faith was the cornerstone of her life. She was active in WELCA from its inception—serving in leadership on the synodical board and at Messiah congregation in Springfield, MO. She was an active volunteer in the community. At Messiah, she will be remembered for her influence on generations of children, having taught Sunday School for over 50 years. The world is a better place because of Nadine Melgren.

- 5. A written recommendation and signature from the applicant's pastor, mentor, unit president or unit representative must be included with this application. The recommendation cannot come from a current or previous board member (within last four years).
- 6. A well-written essay of approximately 500 words, describing applicant's participation in church, school, and community activities, must be included with this application. This essay is the primary determining factor in the awarding of scholarships.
- 7. Award recipients will be notified in May 2025.
- 8. Award recipients will be asked to forward a photo electronically that will be used in synodical organization publications, along with the name and address of their college.
- 9. Individual awards will not exceed \$1,000. Multiple awards may be given in a year.
- 10. It will be the recipient's responsibility to keep the CSS Board Treasurer, Janice Gerken, informed of the college selection and its address, along with the recipient's student ID number at janicegerken@aol.com.
